

## **2018-2019 BRYTHON P. DAVIS SCHOLARSHIP**

**The Scholarship is awarded to students whose parent(s) are currently or have been a regular member of either the United States Navy or Marine Corps.**

### **ELIGIBILITY REQUIREMENTS:**

- Undergraduate student;
- One of the applicant's parents must currently be, or have been, a regular member of either the United States Navy or Marine Corps;
- Full-time enrollment in a degree-seeking undergraduate program at the University of California, Irvine;
- In accordance with the terms of the Brython P. Davis Scholarship, financial need and academic standing will be considered in the selection process

### **APPLICATION PROCEDURES AND REQUIREMENTS:**

1. Students must submit the scholarship application to the Office of Financial Aid and Scholarships by **May 25, 2018**.
2. In addition, students are required to apply for financial aid by:
  - a) Submitting the 2018-2019 Free Application for Federal Student Aid (FAFSA) by **March 2, 2018**.
  - b) Submitting additional documentation, as requested.
3. Students must submit official documents to verify the student's parent(s)' enlistment or honorable discharge (i.e. enlistment records, honorable discharge certificates, certification letter from the Veterans Administration) by the **May 25, 2018** application deadline. Photocopies are acceptable.

### **PLEASE NOTE:**

- The deadline for submission of the Brython P. Davis Scholarship application is **May 25, 2018**. Applications will not be considered after this date.
- Scholarship recipients will be notified in July 2018.
- The award amount of the scholarship is determined by the total amount of eligible recipients each year.
