

## **2019-2020 LAVERNE NOYES SCHOLARSHIP**

**This Scholarship is awarded to students who are United States citizens and blood descendants of a United States Army or Navy World War I veteran. The veteran must have served for at least four months prior to November 11, 1918, and their military service must have been terminated by death or by honorable discharge.**

### **ELIGIBILITY REQUIREMENTS:**

- Undergraduate student
- Blood descendant of a United States Army or Navy World War I veteran who served for at least four (4) months prior to November 11, 1918 and whose military service was terminated by death or by honorable discharge
- Full-time enrollment in a degree-seeking undergraduate program at the University of California, Irvine
- In accordance with the terms of the LaVerne Noyes Scholarship, financial need and academic standing will be considered in the selection process

### **APPLICATION PROCEDURES AND REQUIREMENTS:**

1. Students must submit the scholarship application to the Office of Financial Aid and Scholarships by **May 25, 2019**.
2. In addition, students are required to apply for financial aid by:
  - a) Submitting a 2019-2020 Free Application for Federal Student Aid (FAFSA) by **March 2, 2019**.
  - b) Submitting additional documentation, as requested.
3. Students must submit official documents to verify the military service of the veteran on whom the application is based (i.e. enlistment records, honorable discharge certificates, certification letter from the Veterans Administration) by the **May 25, 2019** application deadline. Photocopies are acceptable.

### **PLEASE NOTE:**

- The deadline for submission of the LaVerne Noyes Scholarship application is **May 25, 2019**. Applications will not be considered after this date.
- Scholarship recipients will be notified in July 2019.
- The award amount of the scholarship is determined by the total amount of eligible recipients each year.
